- 3. Evaluate the organizational structures commonly found in schools and discuss how these structures impact leadership effectiveness and student outcomes. (350-400 words)
- 4. Discuss the role of educational administrators in promoting equity and social justice within schools, and propose strategies for addressing systemic inequalities in education. (350-400 words)
