## **Fall 2026 First-time Freshmen Students Move-In Information**

Fall 2026 First-time Freshmen Move-in will take place August 11-12, 2026. Based on the student's floor assignment in their respective residence facility, they will move into their building on a certain date and time. First-time freshmen do NOT make a move-in appointment for Fall 2026 move-in.

Students assigned to **Wilson Hall** will report directly to a staging area in the Gentry Center Parking Lot at 3639 Walter S. Davis Boulevard, Nashville, TN 37209, upon arrival to campus on their move-in date and time.

### **Wilson Hall Move-in Dates and Times:**

- Tuesday, August 11
  - 1st and 6th Floors: 7:00am - 11:00am
  - 2<sup>nd</sup> and 5th Floor: 11:00am - 3:00pm
- Wednesday, August 12
  - 3rd Floor: 7:00am - 10:00am
  - 4th Floor: 10:00am - 1:00pm

Students assigned to **Eppse, Hale, Rudolph, and New Hall** will report directly to their designated residence facility upon arrival to campus. Exact addresses for GPS usage can be found on our [Move-In webpage](#).

### **Eppse, Hale, Rudolph, and New Hall Move-in Date and Time:**

  - August 12<sup>th</sup>: 6am-9am 1<sup>st</sup>, 6<sup>th</sup> & 7<sup>th</sup> floors; 9am-12pm 3<sup>rd</sup> & 5<sup>th</sup> floors  
12-2pm 2<sup>nd</sup> & 4<sup>th</sup> floors

## Fall 2026 Continuing, New Transfer, and Re-admitted Students Move-in Information

Fall 2026 Move-in for Continuing, New Transfers, and Re-admitted students will take place August 14-16, 2026, by appointment only. The Move-in Appointment Scheduler is accessed through the myTSU Housing Portal. The scheduler opens July 15, 2026, and will close August 13, 2026, at 6:00 p.m. There is a limit on how many people can select for each move-in time slot. For example, only one roommate can confirm the same time slot for a given room and only two suitemates can confirm the same time slot for a given 4-person suite. When you confirm your move-in appointment, you will receive an email with the confirmed date and time. Further information on making and changing a move-in appointment is provided when the student accesses the Move-in appointment scheduler. In order for a returning student to select August 14<sup>th</sup> to move-in you must be in good financial standing for Fall2026 (\$200.00 balance and below) and must be registered for classes.

### Additional Move-In Information for All

If you are running late and will not make it by your scheduled move-in time, whether moving in by floor for first-time freshmen or by moving in by appointment for others, then reach out to notify your Residence Director so that you will not be counted as a No Show. Contact information for the residence halls is on our webpage at <http://www.tnstate.edu/housing> "Contact Us". Students registered with Disability Services will have to contact that department at [DisabilityServices@tnstate.edu](mailto:DisabilityServices@tnstate.edu) to request special arrangements at least two (2) days prior to their move-in date. All early arrivals must receive permission from the University and notify Residence life to set up move-in schedules.

#### Health and Safety Measures:

- Reduced crowding - Students are encouraged to come in one vehicle due to limited parking and to minimize traffic entering campus.
- Health Services will be available to assist if needed.

- Shelter areas- Emergency Management will send updates to ensure proper communication of when and where to seek shelter if there is severe weather. In the event of rain, tents and the pavilion at the Gentry Center will be utilized for cover.

### **Traffic Logistics for August 11<sup>th</sup> & 12<sup>th</sup>**

- Signage for directions and key locations will be present at the perimeter and throughout campus, prior to the move-in opening day.
- For GPS navigational purposes, the physical addresses for where students should enter campus to access their residence facility, are provided on our [Move-In webpage](#).
- Only first-time freshmen students who are assigned to Wilson Hall will go to the Gentry Center Checkpoint at 3639 Walter S. Davis Boulevard, Nashville, TN 37209 on August 11<sup>th</sup> or 12<sup>th</sup>.
- First-time freshmen students assigned to other residence halls will report directly to their respective buildings on August 12<sup>th</sup>.
- After offloading Wilson Hall students' items onto carts and trailers in Gentry Parking lot, parents/guardians will be directed to park in the extended parking areas on the west side of campus near the Health Sciences Bldg. and the Power Plant parking lots from Tiger Belle Blvd. off John L. Driver Avenue and 39th Avenue. Note: The student will stay with their items while being transported from the checkpoint to Wilson Hall.
- Similarly, after offloading Wilson Hall students' items from automobiles escorted to the Wilson Hall top parking lot, parents/guardians will be directed to park in the extended parking areas on the west side of campus near the Health Sciences Bldg. and the Power Plant parking lots from Tiger Belle Blvd. off John L. Driver Avenue and 39th Avenue.
- TSU shuttle will transport parents/guardians from the extended parking area to Wilson Hall.

## REMINDERS:

1. First-time freshmen will move into their residence facility on either August 11<sup>th</sup> or August 12<sup>th</sup>, based on their assigned building and floor.
2. Other students (Continuing, Transfers, and Readmits) must make a Move-In Appointment through their myTSU Housing Portal
3. All students must submit the online Pre Check-In form which is done normally the morning of their move-in date; however, it will become available on August 7, 2026. This is also accessed through the myTSU Housing Portal.
4. Then do the physical check-in and building-specific process at their residence facility. (The process for room key distribution takes place at the residence facility). **Please do not arrive before your scheduled move-in date/time because this could delay your move-in.**
5. Inspect your room upon arrival, and report maintenance issues to your residence facility staff within 48 hours after move-in.
